



General Terms and Conditions for Participation in INTER-NOISE 2016

Berlin, January 2016

1. Registration and invoice

Registration for INTER-NOISE 2016 must be made via the online registration form:

<http://www.internoise2016.org/registration/>.

The registration is binding and the general terms and conditions are hereby accepted by the participant. After having registered, the participant receives a confirmation and invoice. The German Acoustical Society (DEGA), which is financially responsible for INTER-NOISE 2016, will make out the invoice.

2. Payment

The conference fees should preferably be paid immediately upon receipt of the invoice.

Authors can wait with their payment until the acceptance mail has been sent on April 4, 2016. Authors must pay not later than May 17, 2016. A manuscript submitted without the accompanying fee will not be accepted.

Attendance at the conference is only possible upon receipt of payment. Should the conference fee not be credited to the DEGA bank account prior to the conference opening, an on-site payment will need to be made by debit, credit card or cash payment. This requirement also applies to on-site registrations.

3. Cancellation of participation

Participation must be cancelled by writing directly to DEGA (preferably via e-mail to registration@internoise2016.org). For already paid fees please note the following refund policy:

For participants without oral or poster contributions:

If we receive your written cancelation by no later than August 05, 2016, the participant will receive a full refund of registration fee less a flat charge of 50,00 € for bank fees and handling. After August 05, 2016 no refund is payable.

For authors:

If we receive your written cancelation by May 17, 2016 at the latest, the author will receive a full refund of the registration fee less a flat charge of 50,00 € for bank fees and handling. After May 17, 2016 no refund is payable.

Short courses:

Full refunds will be made if any short course is canceled due to low subscription.

For accompanying persons:

If we receive your written cancelation by July 15, 2016 at the latest, the accompanying person will receive a full refund of the registration fee less a flat charge of 20,00 € for bank fees and handling. After July 15, 2016 no refund is payable.

It is not possible to delegate registration to another person. However, the participation of one person can be cancelled (as described above), and a new participant registered by the usual terms.

4. Data privacy regulations

The participant recognizes and accepts that DEGA collects, processes and stores personal data – according to § 28 of the Federal Data Protection Act (German BDSG) – exclusively for processing registrations to INTER-NOISE 2016 as well as for general preparation work for an INTER-NOISE conference.

For this purpose, data is stored by the service provider DC/ConfOrg (<http://www.conforg.fr/index-en.html>).

It may be necessary to transfer your personal data to the organizers of another INTER-NOISE conference. In this instance, you may object to such use at any time (e.g. via mail to registration@internoise2016.org).

5. Copyright

By submitting a contribution to INTER-NOISE 2016, the author confirms that he or she holds the explicit right to use all contents (e.g. texts, pictures) of his / her abstract, paper and presentation. In the case of copyright infringement, the author shall be liable.

6. Miscellaneous

DEGA excludes liability for any program changes or cancellations. Should the conference need to be cancelled completely, already paid conference fees will be refunded.

The correctness of the information stated on the INTER-NOISE website and within the program announcements is not warranted.

The law of the Federal Republic of Germany applies; the place of jurisdiction is Berlin.
